### **Product description**

'Pre-painted galvanized iron, colour-coat type'

is a decorative veneer consisting of a metallic base with a resin paint. The product is composed as follows (seen from exposed side):

Top coating: 15 μmPrimer coating: 5 μm

Chemical treatment layer: 0.4 µm
 Galvanized Iron sheet: 0.6 mm
 Chemical treatment layer: 0.4 µm

- Back coating: 5 µm

Total product thickness: 0.6 mm

## Application/Limitation

Approved for use as low flame spread surface material, not generating excessive quantities of smoke nor toxic products in fire

Approved for use as decorative veneers on any non-combustible substrate.

Maximum organic content: 54 %

Approved colour: off white (E352) and brighter colours

Any adhesive used, other than the one used during testing, has to be tested for low flame spread characteristics according to IMO 2010 FTP Code part 5 and to be approved according to the Marine Equipment Directive and bear the Mark of Conformity.

The product satisfies the requirement for maximum calorific value (ref. Solas Chapter II-2, Reg 5.3.2.2) without further testing.

Each product is to be supplied with its manual for installation and maintenance.
